#### PROGRAM STRUCTURE

There are two components of the 265-hour Professional Colon Hydrotherapy Training with Sofia Reis

#### Part One

200 hours of online learning. The course modules are administered through I-ACT's Cengage learning platform. Student will be given approximately 3-6 months to complete this self-paced course of study. The study modules will include the following topics:

- Anatomy & Physiology
- Microbiology
- Intestinal Health
- Nutrition
- Drug Interactions
- Business Ethics/Office Procedures
- Complementary Modalities

#### Guidance

Throughout this online learning, Instructor will be monitoring Student progress. Support and guidance will be given to Student as they work through each individual module, via various means of communication.

#### **Part Two**

65 hours of in-person training with Instructor. This will take place live, in person in the presence of Instructor, over approximately a 7-10 day consecutive period. There is no possibility of distance or virtual learning for this part of the course.

This training will include the following topics:

- Anatomy and Physiology of the alimentary tract
- Health and Sanitation
- Office procedures
- Practicum including a minimum of 35 client sessions. Student will be practicing client sessions on an FDA registered closed system and/or open system.

## **Equipment**

Student will be receiving training on the closed system equipment: Aquanet EC-2000 or APS100 and Aquawing, from Prime Pacific Health Innovations.

## **Attendance and Missed Training**

100% attendance is expected for the 65 hours of in-person training with Instructor. If Student misses more than two days of classroom training during the allocated period of in-person training, the Student will be charged a full amount for each make-up day. Practicum Practicum includes giving, receiving, and observing 35 sessions. Receiving additional sessions are at student price: \$80/session (after class hours).

#### **CODE OF CONDUCT**

Student will conduct themselves in a professional manner at all times during the Training including and not limited to: the in-person training sessions, the classroom sessions, and in the building where the training is to be held. This includes during the practicum portion of the training - 35 colon hydrotherapy sessions with clients. Based on the discretion of the Instructor, if any misconduct occurs, at any point the Student may be asked to leave or be dismissed from the training with no possibility of refund.

## **TUITION AND PAYMENT SCHEDULE**

#### **TUITION**

The tuition fee is \$3995 CAD + GST and \$1100 USD (Non-refundable).

Also included is the Colon Hydrotherapy Training and "Hands On" training manual, supplies, materials or any other goods related to the instruction offered in this Agreement. The tuition fee will include your membership to I-ACT and associated required fees due to I-ACT. This does not include suggested reading material or elective books.

## **PAYMENT SCHEDULE**

### **CERTIFICATION**

Upon successful completion of this course, Student will receive a "Certificate of Graduation" (Certificate of Completion) from Colon Hydrotherapy Training . The title student will receive is "Colon Hydrotherapist". I-ACT is not a part of Colon Hydrotherapy Training Certification. For I-ACT certification, we will send the following to I-ACT: proof of A&P, High School/GED and CPR certificate to make you eligible for I-ACT Certification where Student will receive the credential of "Professional Certified Colon Hydrotherapist". Student will also be taking the exam with the NBCHT (National Board for Colon HydroTherapy) and receive a credentialing certificate upon passing the exam.

#### **BUYER'S RIGHT TO CANCEL**

Student has the right to withdraw from the Training at any time. You are obligated to pay only for educational services rendered and for returned equipment. Any notification of withdrawal or cancellation and any requests for a refund must be made in writing. Colon Hydrotherapy Training shall pay or credit refunds due within 30 days following the date upon which the student's withdrawal has been determined.

#### **REFUND POLICY**

I understand for registration is \$2000 CA + GST+I-ACT \$1100US. \$1100 from the \$2000CA is non refundable and the \$1100US to I-ACT it is non refundable. This refund will be applied within 1 month from FLC receiving an email for the cancellation and before the training starts. Should the online/in person class be started and not completed for any reason a fee of \$800.00 per day of training acquired is applied. In the case of emergency, the student must write to CHT within 7 days and may transfer the payment for a scheduled class within 12 months, depending on availabilities, with full payment transfer. Once transferred to a future class there is no refund available. I understand that no credit or reduction in cost or hours will be given for any previous training. I also realize that job placement is not promised or guaranteed but resources will be provided when available. All hours missed due to any acceptable reason must be made up to complete this class.
